# 03. Definition of advertising for the purpose of this release form

#### 04. What does this mean for me?

- E. The imagery/video taken may be made publicly available, especially when published on the internet and via social media sites. Under the provisions of the Privacy Act 2020, you have the right to access and request correction of your personal information.
- F. You can, at any time, revoke your consent to the use of your imagery/content with the Content Removal Request form. However, any work used for promotional materials may not be able to be removed until the end of the promotion period.
- G. If we intend to use your imagery/content for purposes beyond the scope originally agreed upon (including, but not limited to, different media formats or larger scale advertising), we will contact you for consent before such extended use.
